## NEW "ANTISEMITISM LAW" IS AN ENCROACHMENT ON OUR FREEDOM OF SPEECH. Why is there minority rule in the U.S.?

<u>DECEMBER 11, 2019 - President Trump signed an executive order that will make Title VI of the 1964 Civil</u> Rights Act apply to anti-Semitic acts. The order is generating concern that it will stifle free speech.

History is repeating itself; antisemitism laws are nothing new:

When the Russian tsar Alexander II was assassinated in 1881 (in a communist uprising to overthrow the monarchy by the group "The People's Will"; Narodnaya Volya), it was discovered that one of the assassins was a Jew. A wave of attacks on Jews (pogroms) erupted. Although officially Jews have never made up more than FIVE PERCENT of the country's total population, they played a HIGHLY DISPROPORTIONATE and probably DECISIVE ROLE in the infant BOLSHEVIK regime, effectively DOMINATING THE SOVIET GOVERNMENT during its early years. In 1919 a decree was issued making It a CRIMINAL OFFENSE to bait anyone on the grounds of their nationality. Lenin wrote on the decree "The Councils Of The People's Commissars makes it incumbent upon all the Soviets of Deputes to adopt resolute measures to prevent antisemitism. Pogrom mongers and pogrom agitators are to be outlawed. - •Calling for, aiding, or justifying the killing or harming of Jews (often in the name of a radical ideology or an extremist view of religion). The Jews want to censor the New Testament. WHY?? - •Making mendacious, dehumanizing, demonizing, or stereotypical allegations about Jews as such or the power of Jews as a collective—especially but not exclusively, the myth about a world Jewish conspiracy or of Jews (research origin of communism/universal Noahide Laws) controlling the media ("I don't care if Americans think we're running the news media, Hollywood, Wall Street or the government. I just care that we get to keep running them.-"Who runs Hollywood? C'mon"By Joel Stein, Dec. 19, 2008), economy (the Federal Reserve was created by and is run by Jews), government (research AIPAC), or other societal institutions (research who runs the porn industry, abortion and the Talmud, anti-white propaganda, anti-gun laws, homosexual agenda etc).
- •Accusing Jews as a people of being responsible for <u>REAL</u> or imagined wrongdoing committed by a single Jewish person or group, the state of Israel, or even for acts committed by non-Jews. (The USS LIBERTY was deliberately attacked by Israel, the survivors are accused of being "anti-Semitic" for requesting a congressional trial; the attack has been whitewashed and covered up)
- •Accusing the Jews as a people, or Israel as a state, of inventing or exaggerating the Holocaust. (Watch David Cole (who is Jewish) In Auschwitz Full Documentary 1992 on bitchute https://www.bitchute.com/video/vAFKVGuW0QL1/)
- •Accusing Jewish citizens of being more loyal to Israel, or to the alleged priorities of Jews worldwide, than to the interest of their own nations. ("I am Israel's guardian in the senate," proclaimed Senator Charles Schumer; also research Johnathan Pollard, former analyst at the Naval Intelligence Center for Counter Terrorism in Maryland who was convicted of spying for Israel.
