

## **Holocaust Conspiracy Theory' Debunked in Less than 5 Minutes**

# **The Impartial Truth**

There are no pictures, plans or war-time documents dealing with gas chambers or any plan to exterminate the Jews, during the supposed "Holocaust". And we can't use the excuse that the 'Nazi's' destroyed all that evidence because we broke the German code and we were able to intercept their secret transmissions, including those from Auschwitz. There were no such plans ever discussed. No numbers were discussed; no techniques discussed or given. Zyklon-B was in widespread use throughout Europe at the time, as a pest control and it was found in all of the work camps, including those that are not said to have 'gas chambers' in them. Aerial photos taken of Auschwitz, during the war, show no signs of people being 'gassed', bodies being burned, or the stores of fuel that would be required to power the crematoriums. World War 2 lasted a total of six (6) years. Assuming they started 'gassing' Jew from 'day 1', that makes for 3,153,600 minutes in the entire six (6) years, which means that Hitler would have had to kill 1.9 Jews per minute for the entire war. Or roughly one (1) Jew killed every 30 seconds.

At Auschwitz, the most famous work camp, there are 15 crematoriums. According to Auschwitz survivors, "Jews would go into the 'chamber', be gassed for 15 to 20 minutes, then be put into ovens". It takes one hour to cremate a body using modern furnaces, which operate at much higher temperatures than the traditional oven of the camp. However, let us assume that the camp's ovens were operating at a level of a modern crematorium that we see today. That means that it would take one (1) hour and twenty (20) minutes to gas and burn fifteen (15) Jews, assuming that they were all burned simultaneously. This is, of course, disregarding the time it would take to empty the gas from the chamber, for the bodies to be transported from the chamber to the oven. The elevators used to transport bodies were very slow and could only take up seven (7) bodies at a time, due to their weight capacity. However, for the 'sake of argument' (in favor of Israel and the Jews) we will assume that the bodies somehow were transported instantly from the chamber to the oven, as soon as they were deceased. That means that fifteen (15) Jews

were gassed and burned every eighty (80) minutes. That comes out to exactly 270 Jews per day, assuming the gassing and burning of the Jews happened every hour straight, without stopping for six (6) years on an uninterrupted basis.

Let's even further round that number up to 300 per day. The total number of killed Jews would be 657,000 . The official claimed tally is that '4 million' Jews were killed at Auschwitz, alone.

The supposed 'gas chambers' do not have gasketed doors. They do not have fireproof switches or wiring, whereas the gas is highly explosive and flammable. The inlets in the roof, that are claimed to have been the point of introduction for Zyklon crystals, were according to senior officials, added after the war. Dr. Franciszek Piper, the senior curator and director of archives at the Auschwitz State museum, admitted on camera to "David Cole", that crematorium one (1), the alleged gas chamber at Auschwitz's main camp, was a reconstruction built by the Soviets, after the war, under direct orders from Stalin. This includes, the fake chimney that is not even connected to the crematorium.

In 1988, an execution expert, Fred Leuchter, who later created the "Leuchter Report", conducted forensic examinations of the 'gas chambers'. Leuchter took samples from four (4) 'chambers' at Birkenau, one (1) from the main camp at Auschwitz and a control sample from one of the disinfestation chambers, that we do know used Zyklon-B which was used to deal with the lice problem. The so-called 'gas chambers' showed almost no traces of Zyklon-B, whereas the disinfestation sample, literally went off the scale. In 1990, the Institute for Forensic Research in Krakow, attempted to refute these results. Their own tests came back with identical results. "Denying the Holocaust" , by the way, is a criminal offense and carries a prison sentence in several European countries.
